Pocket Press for Corporate Seal

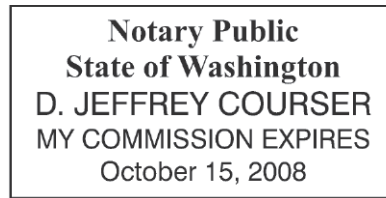
